Guidelines of Digital Sahulat Sarmayakari Account Opening



Introduction:

What is Digital Sahulat Sarmayakari?

Digital Sahulat Sarmayakari allows users to open a Mutual Fund investment Account in JS Investments Limited. Below are the 3 simple steps to be followed:



1. Profiling:

- Verify your Mobile & Email Address.
- Fill all the mandatory required profile details.
- Go through the provided details and confirm.



2. Verification:

- Your CNIC number and shared profile details will be verified through a call.



3. Investment/Purchase:

- Login to JSIL Online Portal (Credentials will be received on registered email).
- Transfer the amount through your bank (Online, IBFT, Kuickpay)
- Submit an Online Investment Transaction.

Step # 1. Profiling:

Log on to <https://online.jsil.com/> and click “Sahulat Sarmayakari Account.”




Complete the registration form

- Valid CNIC Number (Without Dashes).
- CNIC Issuance Date.
- CNIC Expiry Date.
- Cell Number (10 digits).
- Email Address.


- Enter both codes received on email address and mobile number separately.

Fill all the details required to open a Sahulat Sarmayakari Account.

- Personal Details.
- Bank Account Details.
- Account Operating Instructions.



- Go through your provided details and edit if required.
- Accept the disclaimer and submit your request.



Step # 2. Verification:


After receiving Account Opening Request, our Investor Relations Team will call you during working hours to verify your request.

- Telephonic verification of your provided details.
- CNIC Verification through NADRA Verysis.

Step # 3: Investment/Purchase:

After successful verification, you will receive an email on your provided email address having credentials to login JSIL Online Portal or through Mobile App.

After logging in successfully to JSIL Online Portal, go to “Purchase of Units” screen under E-Transactions and follow below steps.

- Select Fund Name.
- Enter Investment Amount (Maximum PKR. 25,000 in a single day).
- Enter the Bank account number from which you are paying for your investments.
- Enter the cheque/Instrument number for the payment(Field below provides IBAN No. for IBFT Transfer).
- Enter the cheque/Instrument date(dd/mm/yy).
- Enter your 4 digit FPIN received on both email address and mobile number (Generate a financial Pin if you don't have it).
- Provide proof of payment by uploading receipt of IBFT Transfer OR scanned copy of cheque and deposit slip.
- Accept the disclaimer and submit your request.

 - JS Islamic Daily Dividend Fund

 - JS Islamic Income Fund
- Per day investment transaction limit is Rs. 25,000/-. No restriction on redemption transaction.
- If the current investments will exceed the threshold limit of Rs. 800000/- then the account will convert into Normal and all the regular procedural guidelines will be applicable.
- Third party payments are not acceptable.
